

## 1. OWNERSHIP AND PURPOSE OF THE TERMS & CONDITIONS

These terms and conditions apply to and must be accepted by all participants attending LALIGA Camps in the summer of 2024. These set out the requirements for participating and content of the event, notwithstanding the fact that some elements may be modified before the start dates.

## 2. LOCATION AND DATES

LaLiga Camps will be held in Madrid between the last week of June 2024 and the last week of July 2024, at the ESC Madrid center. Participants can choose how long they want to stay from 1 to 5 weeks among the following dates:

- 23 - 30 June
- 30 June - 7 July
- 7 July - 14 July
- 14 July - 21 July
- 21 July - 28 July
- 28 July – 4 August

## 3. CENTRO ESC Madrid

LALIGA Camps will take place in Madrid at the ESC LALIGA & NBA facility, located in Villaviciosa de Odón, 30min away from the city center of Madrid.

In the facility there are the residence, an international school, football fields, and other sports facilities.

  - Laboratories

- Classrooms with interactive, spacious and modern digital panels
- Residence
  - 230 rooms with a maximum capacity of 450 guests. (220 double rooms and 10 single rooms)
  - 470m2 dining room
  - 200m2 laundry
  - Cafeteria 130 m2
  - Kitchen 300m2
  - TV and games room 200m2
  - Outdoor pool

#### **4. APPLICATION FORM FOR ADMISSION**

By filling in the interest form on the website of both programs, the request for admission to both programs begins.

Once the user has registered their interest filling out the online form on the website, they will receive an email with the bank details, payment information and consequent access to the final registration form.

The payment must be made in one unique transfer at the bank account provided in the email. LALIGA will not accept any kind of installments.

To complete the enrolment, families must insert all the information requested in the registration form. Families also have to upload the following documents which will be required:

- Proof of payment
- ID/Passport of the person who is doing the registration.
- ID/Passport of the child who is going to participate in LALIGA Camps.
- ID/Passport of the person who will make the payment (owner of the bank account which the payment to LALIGA will be made from).

The online platform will request some personal data from the father/mother/legal guardian who will have to fill out the form, mandatory, to complete the enrolment of the child. Personal data and information related to the football experience of the player will be requested as well.

The parents or legal guardians of the participant, will be taken as emergency contact in case of we need to reach out.

#### **5. REQUIEREMENTS TO PARTICIPATE IN LALIGA CAMPS**

In order to participate in the CAMPS Madrid program, from LALIGA Academy, the following requirements must be met:

##### **5.1 CAMPS Madrid Internal**

- Be between 10 and 17 years old at the time the program is held.

- Have a sufficient level of Spanish or English to communicate with the rest of the players, the coaches and the remaining staff.
- Not be injured or in the process of recovering or rehabilitating an injury that prevents them from complying normally with football activities of the programs continuously over time.
- Enjoy a good state of health.
- Have all the documentation that, depending on the country of origin, is necessary to travel.
- To accept the Disciplinary Regulations of the CAMPS Madrid.
- To accept the rules of internal use of the ESC LALIGA & NBA facility.
- Complete and provide all the documentation required.
- Photocopy of travel insurance for international trips.

### **5.2 CAMPS Madrid Day Camp**

- To be a permanent resident in the Community of Madrid, being able to prove his registration of residency.
- To be between 8 and 17 years old at the time the program is held.
- To have a sufficient level of Spanish or English to communicate with the rest of the players, the coaches and the remaining staff.
- Not be injured or in the process of recovering or rehabilitating an injury that prevents them from complying normally with football activities of the programs continuously over time.
- To enjoy a good state of health.
- To accept the Disciplinary Regulations of the programs.
- To accept the rules of internal use of the ESC LALIGA & NBA facility.
- Complete and provide all the documentation required.
- To have your own accommodation outside the ESC LaLiga&NBA centre.

### **5.3 Participation of children with physical disabilities or neurodivergences:**

- It's a fundamental requirement for participation in our camps that parents or legal guardians notify LaLiga of any disability or neurodivergence that may impact the child's experience in the program. This information should be shared fully and transparently in the enrollment form or otherwise communicated to program management in advance.
- By notifying the team, our team of professionals can evaluate and prepare the necessary resources in order to guarantee a safe, inclusive, and enriching experience for all participants, including those with unique needs. Any information shared will be treated with strict confidentiality and utilized exclusively for the purpose of improvement the quality of the child's experience in the camps.
- In the event relevant information is not shared with the team with sufficient advance notice, the organization reserves the right to take appropriate measures, up to an including expulsion from the camps. A failure to provide advance notification of any disability or neurodivergence that might require special arrangements could negatively affect the ability of the organization to provide adequate support.

## **6. PROGRAMS' REGIME**

The Camps Madrid program will be full-time (morning and afternoon activity) during the dates established for the program.

Camps Madrid program will have the following services:

**CAMPS Madrid Internal**

- Accommodation Services
  - Full board (breakfast, morning snack, lunch, afternoon snack and dinner) with standard sports menu.
  - Sportswear laundry service (twice a week), to be determined by the management.
  - Access to all the services of the complex (Gym, common areas, and game room, library, swimming pool, WiFi)

The organization of the programs will provide food and drink to the participants, both in the residence where the participants are staying, and during the activities to be carried out, as well as in the eventual excursions and trips that are made.

The assignment of bedrooms and roommates will be done by the management of the Camps Madrid following our internal policies and procedures.

- Monitoring service
  - Monitoring: personal monitoring of the student throughout the program.
  - Accompaniment: the athletes will be accompanied at all times by the figure of the monitor, who will be responsible for guiding them throughout their stay. A 24/7 service with the aim of ensuring personal well-being.
- Sport services
  - +10 hours per week of individual and group training.
  - 5 hours per week of matches and/or competition with the rest of the participants.
  - Specific training for goalkeepers.
  - Workshops for players.
  - Attendance at events.
  - Medical service and physiotherapy (in case of damage and injury prevention).

  - Half-full board (morning snack, lunch and afternoon snack) with standard sports menu

- Monitoring service

  - o 5 hours per week of matches and/or competition with the rest of the participants.
  - o Specific training for goalkeepers.
  - o Workshops for players.
  - o Attendance at events.
  - o Medical service and physiotherapy (in case of damage and injury prevention).

If, due to the existing situation related to the COVID-19 virus, some of these activities are discouraged, they will be replaced by other sports or recreational activities.

The program is not definitive and may be modified during the celebration of the Camps.

## 8. ARRIVALS AND DEPARTURES

### CAMPS Madrid Internal

The arrival of local players who will not be requiring an airport transfer and who will be arranging their own private transportation to the facility must take place on Sunday between 16:00 and 19:00.

Players arriving on any date before or after the launch day of the LALIGA Academy Madrid Camps will not be admitted, and LALIGA will not take responsibility under any circumstances in those cases.

At the time of departure, those players who will not be requiring an airport transfer and who will be arranging their own private transportation should play to leave the center between 10:00 and 12:00 Sunday morning, with those responsible for transporting the players having been informed in advance.

No players will be permitted to depart on any of the days prior to or after the final days of the LALIGA Academy Madrid Camps will not be admitted, and LALIGA will not take responsibility under any circumstances in those cases.

### CAMPS Madrid Day Camp

Day Camp players have to arrive at 8:45am to start training at 9:30am.

Day Camps players can leave the facility at 7pm, being picked up by their parents or legal guardians previously accredited. The Camps management always has to know in advance you will be the person responsible for picking up the child.

If any player needs to leave earlier, parents or guardians have let the staff know in advance via email at [laligaacademy@laliga.es](mailto:laligaacademy@laliga.es).

If there is any change in the schedule, LALIGA will let the families know about it via email.

## 9. PRICE

**10. SERVICES INCLUDED IN THE PRICE**

The indicated price includes the following:

- o Transportation from the airport to the ESC LALIGA&NBA Center on the first day: 4 shuttle transfers at 9.00, 12.00, 15.00, 19.00.
- o Transportation from the ESC LALIGA & NBA facility to the airport on the last day: 3 shuttle transfers at 7.00, 10.00, 12.00.
- o Internal transfers to excursions.
- o Full board accommodation during all days of the programme (Only for Internals).
- o Football training.
- o Leisure / activities for tourism to be determined.
- o Private medical insurance for injuries, illness and accidents.
- o Laundry and cleaning service (Only for LaLiga Camps Internal).
- o Sports clothing and equipment (training kits, streetwear and equipment for games).

**11. EQUIPMENT THAT PARTICIPANTS SHOULD BRING**

Participants in the Camps Madrid program must bring enough clothing and sports equipment for the whole time they stay in Madrid with LALIGA, and, in particular, they must bring:

- Football cleats
- Goalkeeper gloves (if applicable).
- Shin pads.
- Sneakers.
- Reusable masks.
- Swimsuit, flip flops and swimming pool towel.
- Complementary street clothes.
- Hygiene products.
- Medication (if applicable).

LALIGA does not take responsibility of loss of money or personal items during the course of the program; we recommend that participants carry no more than €100.

Under no circumstances will LALIGA safeguard cash belonging to the participants in LALIGA Academy Camps Madrid. There however will be an option to safely store passports and identification cards.

Mobile phone usage will only be allowed during LALIGA established times so as not to interfere with the programmed activities. During the course of the program activities mobile phones will be stored by the guardians who will keep them on their persons.

## **12. PROCEDURES FOR REGISTRATION**

- Access the registration form via the website <https://www.laligaacademy.com/camps>
- Read all of the requested information in detail, including the payment information.
- Fill in all required information in the pre-registration form.
- Facilitate the payment via bank transfer.
- Upload the payment confirmation, DNI of the person registering the LALIGA camps participant, and the person making the payment, in addition to having completed the requested information in the form.
- Confirmation of enrollment
- We will then be in touch via Email to confirm the participant's spot in the camps.
- Once confirmation of registration in LALIGA Academy Camps Madrid, we will be in touch with the participants to request the following information: Medical history and allergies.
- One month before the start of the camps, we will distribute a form requesting from all participants information related to their medical history and allergies.
- In the event the participant or legal guardian does not complete the form related to allergies, intolerances, or dietary restrictions, LALIGA resolves itself from any responsibility related to adverse consequences that may arise as a result.
- Arrival and departure logistics.
- One month before the program start, the participant should inform LALIGA of their arrival and departure logistics as well as request the airport transfer service if needed.  
In the event this information has not been received within 2 weeks of the arrival of the player, it will be assumed that the participant will arrange their own transportation.

## **13. CHANGES OR ERRORS IN THE ENROLMENT**

Changes or errors that occur at the time of registration must be notified up to 10 days after registration in the program. After that period, no change or associated refund of the amount paid will be made.

## **14. METHODS OF PAYMENT**

The payment must be made by bank transfer at the bank accounts provided by LALIGA via email. LALIGA will accept a unique payment for the whole amount only, paying for the 100% of the full price at the moment of completing the enrolment.



Families must upload the proof of payment on the online platform to complete their application and to confirm the enrolment of the child in the Camps Madrid. Besides, families must provide information about the person who makes the payment and the origin of the funds.

#### **16. POLICY AND ACCEPTANCE SANCTION REGIME AND ACADEMIC AND ADMINISTRATIVE**

By participating in the admission process, reservation of a place and enrollment in the program, the student fully accepts the regulatory and sanctioning regime that governs the sports programs of Camps Madrid of LALIGA Academy.

Likewise, the formalization of the enrollment by the student, with the signing of the electronic enrollment form, expressly implies their knowledge and acceptance.

#### **17. POLICY AND ACCEPTANCE INTERNAL USE REGULATIONS OF THE ESC LALIGA&NBA FACILITY**

By participating in the admission process, reservation of a place and enrollment in the program, the student fully accepts the Internal rules of use governing the ESC LaLiga & NBA facility.

Likewise, the formalization of the enrollment by the student, with the signing of the electronic enrollment form, expressly implies their knowledge and acceptance.

In the event that any of the rules contained in the Internal Use Regulations governing the ESC LaLiga & NBA facility differ from any of the rules contained in the Regulatory and Sanctioning Regime governing the Camps Madrid and LALIGA Academy sports programmes, the rules contained in the Regulatory and Sanctioning Regime governing the previous two sports programmes will always prevail.

#### **18. POLICY AND ACCEPTANCE OF TRANSFER OF IMAGE RIGHTS**

Via the online registration form completed during the admissions process, students must accept or reject usage rights of their photos, voice, and name, by LALIGA Group International, S.L. ("LALIGA"), with NIF: B-05421805 and address of Calle Torrelaguna 60, 28043, Madrid, as per the terms below, AUTHORIZING LALIGA to procure and publish photographic and audiovisual information of the activities realized under the Campamento de Tecnificación Futbolística (CAMPS Madrid de LALIGA Academy) brand in which minors may appear. The images and videos will be used for informational and marketing purposes to promote the activities of LALIGA via publication in the following ways:

- Website of any LALIGA Academy program and any related magazines, brochures, or other print media.
- Social media of any LALIGA Academy program: Facebook, Twitter, Instagram, YouTube...
- Multimedia content published on the website of any LALIGA Academy program or produced for distribution to participants.
- Informational documents and marketing materials related to any LALIGA Academy program, including but not limited to brochures, informational banners or displays, posters, etc.

- Informational emails related to LALIGA Academy programs sent to parents and guardians of the participants.
- Provision of images obtained via photograph and/or video to third party collaborators with the aim of promoting or implementing any LALIGA Academy program, including but not limited to television advertisements, internet, or social media.

LALIGA Group International, S.L. will ensure that the use of these images in no case damages the reputation of the minor, nor acts against the interest of the minor, in adherence to legal guidelines as outlined in the Ley de Protección Jurídica del Menor and any other applicable laws and regulations.

This authorization will remain in effect across all jurisdictions for a period of ten (10) years, without any financial compensation, and with the ability to sublicense to third parties, and signatories rescind the right to sue for financial compensation, payment, reimbursement, or indemnization.

## **19. CANCELLATION/RE FUND POLICY**

### **1.- Exercise of the right of withdrawal**

The participant has the right to cancel their registration with Camps Madrid of LALIGA Academy during the 7 calendar days following the date of registration. Withdrawal must be communicated in writing to LaLiga, for which purpose a "WITHDRAWAL FORM" is provided, attached at the end of this Registration Terms and Conditions Document. The form must be sent to the following email: [laligaacademy@laliga.es](mailto:laligaacademy@laliga.es)

This communication will be valid as long as it is sent within the indicated period. It will not be necessary for you to tell us the reason for your withdrawal.

The money that you have paid will be refunded within 14 calendar days from receipt of your communication.

### **2.- Cancellation of participation and applicable rules.**

In the event that a participant wishes to cancel their registration, the price return rules that will be applied by the organization will be the following:

In the event that, and as a general rule, the student having been admitted to one of the two established programs and this, for voluntary or involuntary reasons or for other circumstances, whether due to fortuitous cause or force majeure, wishes to unsubscribe, the amounts delivered in favor of LaLiga will not be returned without the prior evaluation and approval by its Management, and said circumstance must be communicated in writing through an online instance to the Admissions Department of this entity, and the cancellation form or dismissal established in the terms and conditions of the program.

The amount related to the reservation of a place or first payment will be refunded, exclusively, in the event that the program in which they are pre-registered will not be taught because the minimum number of students established by LaLiga has not been enrolled.

The student who, prior to the beginning of the corresponding academic year or during its course, unilaterally abandons the program due to fortuitous cause or force majeure reliably accredited and in

writing, will have the right, after evaluation and approval by the admissions department of LALIGA Academy, to the return of the amounts previously paid for academic fees.

Refunds to be made due to cancellations will be paid from September 1<sup>st</sup>, 2024.

Cancellation must be requested in writing by sending the "CANCELLATION FORM" to the following email: [laligaacademy@laliga.es](mailto:laligaacademy@laliga.es). The aforementioned Form is attached at the end of this Registration Terms and Conditions Document.

### **3. Voluntary cancellation during the LALIGA Academy Camps Madrid celebration**

If the player decides of his/her own will to leave the LALIGA Camps Madrid program during his/her stay, the amounts previously paid will not be refunded. LALIGA reserves the right not to refund the amounts requested and already paid by the participant.

### **4. Cancellation during the LALIGA Academy Camps Madrid for disciplinary reasons.**

If the registered player violates the rules of the ESC LALIGA & NBA facility, and therefore receives a sanction by the management of the program that entails his/her expulsion from the camps, the amounts previously paid will not be refunded. LALIGA reserves the right not to refund the amounts requested and already paid by the participant.

### **5. Cancellation due to force majeure**

In the event that the programs had to be canceled due to force majeure (for example COVID-19), the organization will be exempt from any loss that is generated to the participants by the contracting of services outside the programs (for example plane tickets, accommodation or complementary activities, etc....).

In the aforementioned case of cancellation of the programs due to force majeure (for example restrictions derived from COVID-19), laliga undertakes to reimburse the participants 100% of the amount paid.

If the causes of force majeure arise once the programs have started, LALIGA will not be obliged to reimburse any amount.

### **6. Cancellation due to visas and invitation letters**

If the visa gets denied, 100% of the paid amount will be refunded. If the visa application is made outside the deadlines established by each embassy or other procedure, the refund will not be accepted by LALIGA. If a letter of invitation is requested from participants, LALIGA will collaborate by issuing letters; in no case will they be issued to adults or companions. The issuance period being 24 to 48 hours once the request has been made and once the registration and payment for the LALIGA Academy Camps Madrid place has been correctly completed.

### **7. Refund Policy**

In the event that LALIGA decides in favor of a refund, notwithstanding the fact that it is under no obligation to grant one, returns related to cancellations will be issued after 1 September 2024, via bank transfer.

LALIGA is under no obligation to issue refunds in advance of that date.

Refunds will be issued to the same bank account and account holder from which the original enrollment fee in the program was paid. Under no circumstances will refunds be issued to a different account or account holder.

## **20. RIGHTS OF MINORS**

LALIGA, in conformance with laws and regulations related to the rights of minors and adolescents related to protection against violence, has implemented a system to evaluate risks, protocols, and procedures in collaboration with its Office of Protection of Minors.

These measures are structured to enforce adherence to maintaining the fundamental rights of children in order to safeguard their physical, psychological, and moral integrity vis a vis any form of violence.

By extension, LALIGA together with its departments of Compliance, Internal Controls, and Protection of Minors has appointed key individuals to act as delegates in ensuring the safety and protection of minors.

## **21. MEDICAL ASSISTANCE AND INSURANCE**

The insured party will be the participants enrolled in LALIGA Academy Camps Madrid and as such open communication will occur with the insurance company regarding necessary personal information in order to procure the policy. The insurance company will be contracted by LALIGA.

LALIGA ensures that urgent medical care will be covered for any injury arising during the athletic activities and other programming of LALIGA Academy Camps Madrid via the insurance provider contracted by LALIGA, including any illness contracted during the duration of the program.

Exceptions to the aforementioned covered are listed below:

- Incidental costs related to illness and injuries preexisting prior to the signing of documents and registration in LALIGA Academy Camps Madrid.
- Self-inflicted injuries caused by the Insured, including suicide, attempted suicide, or general self-harm.
- Any specialized medical treatment not directly related to accidents covered under the policy.
- Injuries and other consequences resulting from aggression, fights, or delinquent activities in which the Insured acts or intervenes.
- Injuries that occur while in a state of mental incapacitation, inebriation, or under the influence of narcotics.
- Hernias of any kind, lower back pain, back pain, neck pain and muscle tears that are not a consequence of what is previously outlined as insured activities, in accordance with the provisions of the previous clauses.
- Pathologies resulting from the ingestion of unsafe foods.
- Under no circumstances will transportation or lodging outside of a hospital be included in the coverage, with the exception of emergency transportation to a medical facility from the time of the corresponding accident or injury covered by the policy
- Accidents occurring prior to the effective date of the policy will be excluded from coverage as well as any expenses derived directly or indirectly to such an accident.

The duration of the policy will be non-recurring and exclusively limited to the duration of the Insured's participation in LALIGA Academy Camps Madrid.
